

#### **Annual Financial Report Due September First**

All 4-H Clubs and Groups with a checking and/or savings account must submit an **Annual Financial Report and supporting documents to the 4-H Program Educator by September 1** or the date set by the 4-H Program Educator. The Annual Financial Report and supporting documents include:

- 1. Wisconsin 4-H Clubs & Groups Annual Financial Report
- 2.4-H Club or 4-H Group Audit Checklist
- 3. Copy of the checkbook and/or savings registry, covering July 1 June 30
- 4. Copy of the bank statement ending June 30 or July 1 for each account. Any differences between the bank statement(s) and the ending balance reported must be reconciled. Upload the reconciliation with the Annual Financial Report.
- 5. Current inventory of land, buildings, property, or project equipment with individual values of \$2,000 or more.
- 6. Monthly Treasurer's reports for 4-H Clubs or Groups with annual income greater or equal to \$20,000

The Annual Financial Report allows the 4-H Club or Group to qualify for federal taxexempt status under the University of Wisconsin Board of Regents General Exemption Number (GEN) for Wisconsin 4-H Clubs and Groups.

Failure to submit a completed Wisconsin 4-H Clubs & Groups Annual Financial Report and supporting documents by the due date could result in loss of tax-exempt status and forfeiture of all financial assets.



#### **Record Books, Due September 1st to the Extension Office**

As summer comes to a close it is time to start reflecting on the 2023-2024 4-H year. Record books are part of the reflection process for the 4-H year. Club members can create a record book to reflect on their projects during the year. Visit either the <u>Jackson</u> or <u>Trempealeau</u> County websites to get the pages for your record books. Record books do not have to be in the typical form. Members can use the record book forms for the content then they can put that information into a slideshow, a website, or a different form that they prefer.

Record books will be judged for growth in project areas. Youths should be sure to focus on that with their records.

#### Re-enrollment for the 4-H Year

The 4-H year is from October 1st-September 30th. Every year members are encouraged to re-enroll in <u>4-H Online</u> to stay connected to the program and get all the proper updates. The soft deadline to enroll is **November 1st.** After this date, the old mailing list will not be used to bother old members who have aged out or are not re-enrolling. Current members should be enrolled and have their projects finalized by **April 1st.** 

Enrolling is important. It keeps you and your family included in the great opportunities that 4-H has. It is also an opportunity to update your contact information. Make sure the email address you the the most is used for your family email. This is the one I use for both the 4-H newsletter and the club lists that are shared with leaders.

If you are an adult volunteer be sure you have completed all of the required trainings. Here is a link to the State 4-H website that has all of the trainings and details about them.

#### **Cedar Crest Icecream Flavor Contest**

Madison, WI [August 2024] — Cedar Crest Ice Cream, headquartered in Cedarburg, Wisconsin, and the Wisconsin 4-H Foundation have teamed up again to present the "Cedar Crest Ice Cream 4-H Flavor Creation Contest" for Wisconsin 4-H clubs. All Wisconsin 4-H clubs can submit their idea for a new ice cream flavor, along with a flavor description and interesting flavor name. Entries are accepted September 1, 2024, through November 15, 2024.

Five finalists are selected by a panel of Cedar Crest Ice Cream flavor experts from all entries received. One flavor is awarded top honors and a \$500 gift. The winning flavor will make its debut in parlors in the summer of 2025. All five finalists receive an ice cream party for their 4-H club.

"Cedar Crest Ice Cream is known for its variety of flavors," says Robert Kohlwey, Vice President of Sales for Cedar Crest Ice Cream. "It is a real joy to see the imaginative flavor ideas submitted by our creative 4-Hers across the state."

According to Brenda Scheider, Executive Director of the Wisconsin 4-H Foundation, the contest is a great opportunity for 4-H youth to work together to develop and name their flavor. "The most exciting part of the contest is the winning flavor will be available in parlors that scoop Cedar Crest Ice Cream next July."

The contest has been an annual tradition for over ten years. Recent winning flavors of the annual contest include Haystack, created by the Knellsville 4-H Club of Ozaukee County, and Wisconsin Campfire S'mores, created by the Springbrook 4-H Club of New Richmond. The winning flavor for 2024 was Paul Bunyan, created by the Pesobic Pathfinders 4-H Club of Lincoln County.

Cedar Crest produces more than 80 flavors of ice cream, along with frozen custard, sherbet, and sorbet at its Manitowoc, Wisconsin, plant, and distributes products in parlors and retail locations in Wisconsin and beyond. Several of the flavors now in regular production, including Wisconsin Campfire S'mores and Big Muddy, are a result of the contest.
